Transfer Updates

Fall 2024, Spring 2025, Fall 2025 – Active Pathways

- 73 updated similar pathways at 10 campuses over 30 TMCs
 - Communication Studies 1.0/2.0 Updates
 - 45 Comm Studies 1.0 pathways with 18 campuses
 - 19 Comm Studies 2.0 pathways with 9 campuses, so far

GE Review Update



- Current GE review cycle:
 - Course proposals for 2024-2025 academic year.
 - Approximately 3,881 proposals (CSU GE Breadth, AI, and IGETC).
 - Approximately 235 Ethnic Studies courses (included in total).
 - Dr. Rob Collins continues as the CSU Ethnic Studies Faculty Coordinator.
 - CSU GE Area E decisions published first.

 - Moving to 2nd level phase and reconciliation this month.

- Will ICAS or our System Offices produce a Guiding Notes for GE Reviewers based on Cal-GETC? It was also noted that ICAS might have more information on the updated Cal-GETC Standards tentatively in May 2024, but that is the end of the current Curricular Review cycle on most campuses. Will we get clearer guidelines or any updates prior to that?
- There will be no changes to Cal-GETC Subject Area requirements in May 2024.
- The Chancellor's General Education Advisory Committee (GEAC) will review the Guiding Notes to determine changes necessary for the next version (2024). Please refer to the Cal-GETC standards for all subject area requirements that will be implemented Fall 2025.

- IGETC/Cal-GETC course use: Example - student completes an approved IGETC 1A English Comp course at a CCC in 2023 or 2024. May CCCs certify this IGETC 1A course towards Cal-GETC area 1A?
- The Cal-GETC committee is reviewing the standards to determine appropriate changes for course eligibility. Committee recommendations will go to ICAS this spring for review and/or approval.
